2 POLICE REPORT

2.1 Incidents since last meeting

6 ALLOTMENTS

6.1 Proposal for allotment parking area inside the first gate. Neighbour concurrence received via email. Requires removing prone Goat Willow (see **APPENDIX I**), TCA request submitted to BDBC.

AGREED Unanimously

- Work will include widening of entrance when conditions sufficiently dry. Preparing parking area will need digger, tree stumps can be removed at same time. PGGM (Premier Grounds and Garden Maintenance) (Lengthsman) to provide estimate.
- Tree planting in the allotment field. Also wildflower planting see *Villager* article **APPENDIX II**.

TO RECORD Thanks to tree warden John McLean.

6.4 New allotment holders. Expression of interest received for double plot including the fruit cage. Allotment agreement to be revised.

7 HIGHWAYS / RIGHTS OF WAY

7.1 Lengthsman task completed

- i Cleared pavement A30 to M3. Note to HCC pavement needs resurfacing.
- ii Cleared grips along Greywell Road from A30 to Up Nately.
- iii Fixed the fingerpost at Tunworth Rd /Greywell Rd Junction. Brackets etc were worn, decayed, and the fingers rotating freely. Impossible to tighten; solution to dismantled, reassemble, then drilled and bolted.
- iv Cut back Laurel hedge covering road sign Greywell Road opposite Blackstocks Lane junction (opposite Up Nately Pond).
- v Cleaned entrance barrier to Village Hall.

AGREED Unanimously. Good work done, significant improvement.

7.2. Verge north of Old Greywell Road opposite Oak Tree Cottages. Chairman has contacted owners English Rural Housing who will come out to inspect.

7.3 Cycle path at the Hollies

ACTION Continue attempts to establish who is responsible – and to register as Right of Way. To remove litter contact BDBC street cleaning.

7.4 Pavement M3 to A30. Tree branches from SSSI land obstructing the pavement. ACTION Kevin Rafferty volunteered to cut back and clear.

7.5 Localised Highway flooding

- i Tunworth Road before pond Highways inspected and allocated to contractors.
- ii Greywell Road by Pennybridge Farm Requirement for landowners to clear ditches but difficult to enforce. Noted Local Highways Engineer made site visit (with spade) and opened up grips.
- iii Tunworth Road adjacent to Cob Tree Cottages and Greywell Road junction (digger required also site meeting with Lengthsman.).

<u>T/00099/20/TCA</u> Webbs Barns, Tunworth Road, Mapledurwell. T1 Rowan: fell. T2 multi-stemmed Rowan, fell. T3 Cherry, fell. T4 Cherry, fell. To note T4 Cherry is dead and T1 Rowan is decayed at the base. *Comment from Parish Tree Warden:* 'This should be approved. As the Rowan has decayed then that should come down and the multi-stemmed one is of no consequence.'

<u>20/00153/FUL</u> (Validated 24 Jan) Elmwood, Heather Lane, Up Nately. Demolition of outbuilding and erection of 1 no. five-bed detached dwelling with associated access and landscaping. *Parish Council response: Concern regarding the glass walls in the side elevations and potential for overlooking, intrusive impact on neighbours, despite some screening by trees.* (Noting that the plot to the west of Elmwood has current planning approval.)



COMMUNITY FUNDING FROM KEW GARDENS

To embellish the proposed Commemorative Wood in Frog Lane, I applied for wild flower seeds that are being donated by the National Botanical Gardens, Kew. I also found a source of funds from Kew for our village teenagers and those in their early twenties that seems to be worth publicising.

"Grow Wild" is Kew's outreach programme to the public. It has money from The National Lottery and others, based upon and inspired by the Great Outdoors. The organisation is inviting 14 - 25 year olds to dream up and undertake a project that is judged as a really good idea for promoting wild life – either visually, creatively, in a transformational way or even musically! Grow Wild is offering to help each project along with a grant of £500.

The website is www.Growwilduk.com/creative that includes a short video and offers of available support to projects.

It appears that these projects can cover just about anything based upon the inspiration of our UK native plants or fungi. I asked the coordinator about it and received the following reply:

"You might decide to create visual art through painting or photography. Maybe music, poetry or dance are more your thing? How about transforming a space in your community? Or even designing your own fashion collection? Pick something you enjoy doing, involve other people and let your imagination run riot."

Grow Wild was publicly voted the UK's Best Environment Project in the National Lottery Awards on BBC1.
